- Nominations are invited by the Honorary Secretary for the election to the following posts to be elected through postal ballot.

Special Announcement

- Provisions for electronic ballot on an experimental basis has been made and members are requested to exercise this option as well to check the system to be implemented in 2014 for IAPM Elections - 2015. However, it is re-iterated that the result of elections for 2014 will be based on the postal ballot only.

POSITIONS ANNOUNCED:

- President (one post) : Tenure - One year**
 - Vice President (one post) : Tenure - One year**
 - Honorary Secretary : Tenure - Three Years**
 - Hony Treasurer : Tenure - Three Years**
 - Hony Jt Secretary : Tenure - Three Years**
- The duties of the above post are provided in the Bye-Laws of the Association. Bye-laws of the Association Part-III under Para 12 (Election of office bearers)].
 - Every candidate for the post of **President and Vice President** should have at least 10 years standing as Life Member (without interruptions) and have served the Association in one or more ways by being an office-bearer, or being a member of the council or Chapter Chairperson or participating in Symposium/ Seminar at the Annual Conference or as an Organizing Secretary/Chairman. [Part III (Bye-laws of the Association under Para 13 (Election of office bearers) item (vi & vii)]
 - Nominations are to be made on plain paper duly proposed and seconded by Members who do not owe any membership dues (such as Life Members!). The nominated member, **proposer** and **seconded** should provide their IAPM Membership Numbers and sign the nomination.
 - The nominated candidate shall provide (1) a letter of consent and (2) a copy of their bio-data (not exceeding one A4 size page).

Schedule.

- Last date for receipt of nominations is : **31st August 2013.**
- Last date for withdrawal of nominations is : **25th September 2013.**
- Ballot Papers will be dispatched by : **15th October 2013.**
- Last date for receipt of Ballot Papers : **30th November 2013.**
- Counting of Ballot : **05th December,2013**

- Ballot Papers will be despatched only to those members who have cleared all their dues by **31st June 2013** as notified by by the Honorary Treasurer [Part III (Bye-laws of the Association under Para 13 (Election of office bearers) item (ix)]
- **The Association shall not be responsible for any delays / non-receipt of ballot papers due to incorrect address/ postal delays or similar circumstances beyond its control.**
