

Quo Vadis

The Indian Association of Pathologists and L Microbiologists was established in 1949. Several changes have occurred over the years. There has been an enormous explosion of knowledge with subsequent refinement in the form of distinct subspecialties. Paralleling this was the formation of separate associations, societies, academies and bodies for Medical Microbiology, Cytopathology and .Hematology. However IAPM has remained a form of parent body for the community of pathologists and microbiologists. Members of other related associations still retain their roots in the association: at least that is the general perception.

Every association survives on the participation of its members. Office Bearers, generally elected or rarely nominated and certain committed members undoubtedly are given the responsibilities as guardians of the association. However the custodian of the constitution and the functioning of the association undoubtedly is vested with every member both as individuals and as the general body. Since it is not possible for the entire family of members to meet often to take stock, this is invariably limited to an annual meeting of the general body. Thus all important decisions that relate to accountability, progress and future plans of the association are taken during the general body meeting. The general body is undoubtedly the best investment of an association with assured returns and dividends that surpass all economics of growth.

A brief look into the register for general body meetings indicate that in about 18 meetings including special sessions there are 1451 signatures. Thus on an average of 80 of us attend each general body meeting. Even in the last conference with nearly 800 delegates around 81 (about a tenth) attended the meeting. These include certain senior members who attend the meetings regularly and members of the Executive Council. Further there are those who are attracted by the hope of moderating the next seminar or symposium!

Elections is another annual event where despite all efforts including using reply paid postal ballots yields around 500 to 600 votes: a fifth of what is expected.

Therefore it is apparent that there has been reluctance on our part to contribute in the improvement of the association. While it may be argued that general body meetings are only of administrative (political to some) interest and have no place in the itinerary of scientists and academics, it must be realized that such disinterest percolates along all levels. Postgraduate students no longer seem to register as members nor are there any peers to guide them about the association. This year a record number of nearly 70 students who submitted abstracts did not register as members. All these abstracts had members of our association as senior authors. Further routine requirements for award papers were not followed in some cases-despite announcements.

symposia on these topics. In view of her achievements she has not only been conferred several fellowships but was also awarded the Woman of the year 1997-1998 Medal by the International Biographical Center Cambridge, England. Her biographical sketch appeared in Who's Who in the world 15th, & 16th, Edn. (1998, 1999), USA, Dictionary of International Biography 26th Edn. 1998 and "Outstanding Scientists of the 21st. Century", First Edn. by International Biography Center Cambridge, England.

Prof. Bishan D. Radotra is the new Vice-President of IAPM. He is currently a Professor of Histopathology (Neuropath.) at the Postgraduate Institute of Medical Education & Research Chandigarh.

He graduated from Govt. Medical College Jammu in 1979 and completed his post graduation from Govt. Medical College, M. D. University, Rohtak on 1984. He joined PGIMER, Chandigarh the same year and on completion of senior residency in 1987, he was appointed as Lecturer in Department of Histopathology where he has served in several positions in the faculty. In 1991, he was awarded a commonwealth scholarship by Government of UK and deputed to The Institute of Pathology at The Queen's University of Belfast (UK) where he was conferred PhD (Neuropathology) in 1995. Subsequently, he has been awarded membership of National Academy of Medical Sciences in 1996. He was a Visiting Fellow to Department of Oncology, The Queen's University of Belfast 1997.

Neuropathology has been his main interest since 1984, although his other subspecialty interests include Dermatopathology and Endocrine Pathology. He has more than 170 publications to his credit and has also contributed to chapters in books. His work is on brain tumours is quoted in reference books. With over 25 years of experience in teaching and research, Prof. Radotra developed curriculum for one-year postgraduate Diploma course in Neuropathology for the Indian College of Pathologists (ICP) and is recognized as postgraduate teacher by Indian College of Pathologists in 2003 for the training of Neuropathologists. He was appointed by the Government of India as a Member advisory committee to set up postgraduate medical institute at national level in Jammu (J&K state).Prof. Radotra has delivered several lectures and has contributed to numerous slide seminars and symposia. He is well known for his organizational skills and has a wide administrative experience. Prof. Radotra served as Honorary Secretary of Indian Association of Pathology and Microbiology (2002-2004). He is a fellow of Indian College of Pathologists (ICP). He is a life member and fellow of many scientific societies including British Neuropathological Society. He also contributes actively to voluntary service.

Obituary

DR. SADASHIVIAH J. NAGALOTIMATH



Dr. Sadsahivaiah Jambaiah Nagalotimath (SJN) was born at Gadag, Karnataka on 24th July 1940. He was multifaceted: a teacher, a thorough professional, academic, orator, and a writer to name a few. Very rarely do we come across so many facets of human virtues in one individual. His fields of interest and achievements were numerous. However what was always apparent was his perseverance, hard work, and devotion that made him excel academically, socially and spiritually. He was a researcher with a keen sense of analysis, reformer and an efficient organizer. Despite all these qualities he was always unassuming, straightforward, helpful and displayed simplicity that was worth emulating. He served as a role model to many.

Against several odds he completed his MBBS (1965) and MD in Pathology & Microbiology (1970) from Karnatak Medical College, Hubli. His mentor was Prof. M. Krishna Bhargava (Past President IAPM). He then joined J.N.Medical College (JNMC) Belgaum in 1970 at the Dept of Microbiology and became Head of the Department of Pathology in 1974. It was here along with Prof. A.V. Ramaprasad, he developed the renowned Pathology Museum. This is a landmark that has been appreciated both within the country and abroad. It is with this museum he demonstrated his skills in the art and science of museum technology as well as the value of a museum in education.

His tenure at Belgaum literally highlighted the department throughout the country as a centre for quality education. In 1980 the 29th Annual Conference of

His tenure at Belgaum literally highlighted the department throughout the country as a centre for quality education. In 1980 the 29th Annual Conference of IAPM was held at Belgaum. All those who attended the conference recall even today the meticulousness and perfection with which he organized the conference. He pioneered the National CME and PG courses in Pathology at JNMC in 1981, which has retained its popularity amongst residents and consultants largely due to Dr. Nagalotimath's contribution even today. He also organized the Indian Academy of Cytologists conference at Belgaum in 1990.

Subsequently Dr Nagalotimath served as Principal of BLDEA's Medical College at Bijapur from 1991 to 1993. There he established the famous '*Stone Museum*' that has a collection of stones formed in different parts of the human body. From 1994 to 1996 he was Principal of JSS Medical College at Mysore and Director of its hospita. There he organized the 1st International CME in Surgical Pathology and Cytology in collaboration with AIPNA in 1995. In 1996 he was appointed the first Director of KIMS Hubli, where he organized the 2nd International CME in Surgical Pathology and Cytology. In 1997 Prof Nagalotimath was invited to be the Medical Director of BVV Sangh at Bagalkot and Principal of the new S. N. Medical College and HSK Hospital in 2002, which he established literally from scratch. His skills in organization, his efficient ability to establish departments and administrative capabilities thus made him much sought after. Wherever he went he worked with sincerity and conviction that left an indelible mark.

Prof. Nagalotimath's relentlessly contributed to improving the subject of pathology in this country. He served the Indian Association of Pathologists and Microbiologists in various capacities. He was Joint Secretary of IAPM from 1981 to 1983, the Editor in Chief of Indian Journal of Pathology and Microbiology from 1983 to 1987. He served as Secretary of IAPM from 1988 to 1989 and later held the highest office of President in 1993. He was founder member of Indian College of Pathologists (ICP). Later he rose to be the Dean and was presently the Chairman of ICP. Along with Dr Vijay Joshi he was instrumental in starting the International CME in Surgical Pathology and Cytology 'in collaboration with AIPNA in 1995. He was also nominated to be the President of International Academy of Pathology-Indian Division. This distinction of serving all the major academic bodies related to pathology in different positions is unsurpassed. He has been the recipient of several noteworthy awards like 'the Hari Om Ashram Alembic Research Award' in 1986 for his work on bruce1losis. In 1989 he was conferred the Dr B.C. Roy Award for his contribution to Museum Technology. His research contribution included brucellosis, fluorosis, guinea worm, diabetes (pancreatic calcification) and sediment cytology. Dr Nagalotimath was a charming speaker and a great teacher and his proud students are settled all over the world. He was a voracious reader and a voluminous writer. More than 125 of his scientific papers have appeared in national and international journals; and he has contributed several chapters in medical textbooks. He was one of the editors of 'Textbook of Pathology' of IAPM.

His writings in Kannada on medical science (more than 40 books) earned him thousands of fans throughout the Karnataka state. Two of these books got him the Karnataka State Sahitya Academy Award in 1989. His autobiography in Kannada '*Bichhida Jolige*' is considered to be a rare gem. Considering his achievements the Government of Karnataka conferred on him the Karnataka Rajyotsava Award in 1994. Prof. Naga1otimath started a monthly health magazine in Kannada, '*Jeevanadi*' (published from Bangalore) to educate the rural population mainly on health related topic. The magazine has become very popular and has a wide readership. He was President of Karnataka State Vidnyana Parishad for three consecutive terms. In 1986 he started the 'Belgaum Science Centre' for school children which is considered to be the best and a model science centre in the state.

He had a religious bent of mind too, and had close contact with many Swamijis. In fact the Vibhuti on his forehead was a hallmark. He was both traditional and unconventional, combining science with religion. He amazed the Swamijis by reinterpreting Vachanas (poems of life's experience) written by spiritual and social reformers of the past on a scientific and medical basis. He has thus given a new dimension to these Vachanas.

Prof Nagalotimath passed away after a brief illness on 24 October 2006. In him we have lost a multifaceted personality; a life that was always vibrant. Members of IAPM we shall miss him dearly. Sitting in the front row, invariably in a white shirt, shawl wrapped over his shoulders, vibhuti on his forehead and greeting everyone with a smile, he was a part of every annual conference. With all humility he would patiently attend every session. No official meeting of the association was complete without him. Whenever necessary he would give his suggestions and comments in an extremely convincing and logical manner. The association and all those who knew him have lost a friend, philosopher, guide, counsel and above all an excellent human being.

We pray to the Almighty to provide his grief-stricken family members with strength and fortitude to face the loss on his death and we pray that this noble and striving soul may rest in peace!

This is the IAPM House at Cuttack. The mutation work is in progress and IAPM Headquarters is paying the Municipal Holding Tax regularly having been allotted a holding number.

The IAPM House has two floors and the construction for the second floor is underway. This construction has been possible due to the generous grants provided by Sri Surendra Nath and Sri Rudranarayan Pani Honourable Members of Parliament, Rajya Sabha who have contributed Rs.3 Lakhs and Rs.2 Lakhs respectively from the M.P.LAD Funds. Monthly seminar at IAPM House: Academic seminars are organized at IAPM house every month. The monthly seminar is followed by business meeting of IAPM(HQ) advisory committee where the development work of IAPM HQ are discussed and the reports are sent to Hon. Secretary IAPM.

Public Health Awareness Camps: The IAPM Headquarters conducted a blood grouping health camp at Nimur High School, Jagatpur, Cuttack in the presence of Dr. D. N. Lanjewar, Secretary ICP on 9th April 2006. Similar camps were conducted round the year at various places as a voluntary service to the public in general.

Computerization of IAPM Directory: The IAPM Headquarters is maintaining the address of members for the Hon. Treasurer IAPM and updating them from time to time with the help of Dr.N.Rout, Ex-treasurer IAPM. Members are therefore requested to inform the IAPM Headquarters also regarding a change in their addresses. This is an important activity that has been undertaken by the Headquarters of IAPM and will benefit the association and its members. This will also help in publishing the address book regularly.

Storage of documents at IAPM House: The IAPM Headquarters has been over past several years trying to develop an archive of the association. One of the proposals is to stor and record all old journals of the association [Indian Journal of Pathology and Microbiology]. APCON 2006

The inauguration on the evening of 6th December 2006 was in itself a delight. In the auditorium was an extremely rare sight. Three consecutive Chairpersons of our annual conferences held at Bangalore were present: Prof. K.M.Bhargava (1986), Prof. A.V.Ramaprasad (1996) and Prof.S.K.Shankar (2006). The Chief Guest of the evening Prof. P. Balaram, Director, Indian Institute of Science, Bangalore delivered a scholarly speech on the virtues of science and how individual subjects that have evolved are actually complimentary and serve each other. Science can benefit man-kind only when every branch contributes and supplements each other. This set the tone for the conference. Various awards for 2005 were presented during this ceremony.

The Prof. B.K.Aikat Memorial Oration on the Role of the Histopathologist in the era of transplantation was delivered by Prof. Kusum Joshi, President of our association as the inaugural session of the conference on 7th December 2006.. Two masterly Guest Lectures by Dr. Aruna Chakravarty, Leeds, UK [Pathology of Dementia] and by Prof. Jaan Bak, Bergen, Norway [Genomics and Proteomics in Neoplasia] held the audience spell-bound. The Plenary Session for the Dr. K.C.Basu Mallick Award was held on the first day [7th December 2006]. The second day started with the Slide Seminar on Pediatric Pathology moderated by Lt.Col.S.S.Gill from AFMC, Pune. The morning also had the Plenary Session for the Best Paper Award and the Dr. Gaya Prasad Memorial Symposium on the Pathology of Stroke in India moderated by Prof. B.D.Radotra, PGIMER, Chandigarh. The third day commenced with the Usha Hardas Memorial Microbiology Symposium on Reproductive Tract Infections moderated by Prof. Meera Sharma, PGIMER, Chandigarh.

This year a total of 807 delegates registered for the IAPM conference and 375 abstracts were accepted: 103 for oral platform and 272 for poster presentations. Of these, 98 papers and 243 posters were presented. The local organizers very kindly awarded two prizes each for the best posters displayed on the on the 7th [Dr. Babina B. Thangjam, Bharati Vidyapeeth Medical College, Pune and Dr.Geetha JP from JJM Medical College, Davengere] and 8th December [Dr. Sakshi Malhotra, KMC Mangalore and Dr. Nisheena Raghavan, St.Johns Medical College, Bangalore]. In addition there were poster quizzes [another first] in Pathology conducted by Dr.N.Jayaram and in Microbiology by Dr. Satish Ambernath.

Several new sessions were introduced by the IAPM for the first time under the "Postgraduate Series". A session on Careers in Pathology by a galaxy of speakers was an

eye-opener for the young and the old! Prof. K.P.Aravindan and Prof. Anita Borges enthralled the audience debating on Mitotic Figures are the sine qua non of malignancy. The How I do it session generated keen interest with a video on demonstration of esophageal varices at autopsy [Dr. D.N.Lanjewar], examination of urine [Dr.A.K.Dinda] and How to improve your presentation [Mr. Yogesh Kumar]. There were two new parallel symposia: one in Microbiology [Chlamydial Infections moderated by Dr. Gita Sathpathy Panda] and in Hematology [Vascular Thrombo-embolism: Role of Laboratory Physicians moderated by Lt.Col.(Dr.) Deepak Mishra]. A panel discussion on IAPM Guidelines : The beginning or the end? saw the use of voting pads for the first time. Breakfast sessions by different subspecialty groups completed the list.Some of the groups discussed matters that would go a long way in improving diagnostic, teaching and research activities in their respective fields.

The best of Udipi cuisine, cultural show by medical students and a banquet with a laser show, songs and dance with a palace as a backdrop provided the right relief from the hectic academic sessions.

Minutes of the 55th General Body Meeting held on Friday 08th December 2006 at 18.30 Hours at the NIMHANS Convention Centre, Bengaluru, [Bangalore] [Venue of the, 55th Annual Conference of IAPM (APCON 2006)]

he Meeting was held with Prof. Kusum Joshi, President IAPM in the Chair.

A total of 81 members attended the meeting that was adjourned at the commencement and resumed thereafter since the required quorum was incomplete [as laid down in the General Procedure of Meetings of the association No 7 of III: Byelaws]

Prof PV Patil, Past President IAPM, Prof. M.K. Singh, Vice-President, IAPM and Dr. Niranjan Rout, Past Treasurer IAPM had expressed their inability to attend the meeting to the Honorary Secretary verbally.

The Honorary Secretary received news of the sad demise of the following honourable members of the association:

(i) Dr. D. N. Lanjewar informed about the sad demise of one of our Past Presidents [1983], Dr. G.V Talwalkar [L/1966/772] on 09 March 2006.

Dr. D. N. Lanjewar also kindly provided a photograph and an obituary. Dr. Shubhada Kane also helped in editing the obituary. The obituary and the photograph of Dr. G.V. Talwalkar (18 April 1923 -09 March 2006) was printed in the IAPM News Bulletin (Vol 03/06 page 03, May-July 2006 issue)

(ii) The passing away of one of our active Life Members, Dr. Nalini Venugopal [L1976/521] on 31 May 2006 was obtained from the ICP News Bulletin.

Members were informed of the sad news in the IAPM News Bulletin (Vol 03/06 page 03, May-July 2006 issue). Subsequently Dr. Francisco Couto helped in providing the obituary and the photograph of Dr. Nalini Venugopal (30 December 1944-31 May 2006) which were printed in the next IAPM News Bulletin (Vol 04/06 page 03, August-October 2006 issue)

(iii)Dr. Prakash V. Patil informed through an E-mail the sad demise of one of our revered Past President, (1993), Honorary Secretary (1988-1989), Honorary Editor (1983-1987) and Honorary Joint Secretary (1981-1983) Dr. S.J.Nagalotimath [L/1968/508] on 24 October 2006.

The sad news was printed in the IAPM News Bulletin (Vol 04/06 page 03, August-October 2006 issue). A befitting obituary of Dr. S. J. 3.2 : Implementation of Constitution Rules (II NO. 4) wherein members of Chapters should be primarily Members of IAPM

According to the above rule of the Constitution, members of Chapters should be Members of the parent association. It is necessary to implement this rule since the status of Chapters is that of a branch of the IAPM but not an independent body.

3.3: New Proposal Form for Membership

As discussed in the previous meeting of the Executive Council and the General Body [Item 3.1], the existing Proposal Form needed to be redesigned to make it more clear and friendly. This had been done. This form can also be downloaded from the IAPM website [www.iapm.net.in].

Some forms have been provided to the Honorary Treasurer and any other member who needs these forms can collect them from the Honorary Secretary.

3.4: New Membership Directory

The new IAPM Membership Directory has been printed. The previous Honorary Treasurer Dr Niranjan Rout was responsible for completing this Herculean task.

The efforts of Dr. Niranjan Rout were gratefully acknowledged by the members.

Some members felt that instead of arranging the names in the order of the IAPM Membership numbers this should be done alphabetically. It was pointed out that a alphabetic list is provided as an index and the members could refer to this to determine the IAPM Number that could then be used for tracing the required information. However it was still felt that in future an alphabetical list should be available.

Dr. Niranjan Rout had mentioned to the Honorary Secretary that since the cost of preparing and printing the Directory in the form of a book is expensive, a CD may be a cheaper alternative. This suggestion was appreciated by the members. However it was felt that since CDs would require ready access to computers and may be easily duplicated, for the time being the existing practice of printing books should continue.

3.1: Admission of new members to IAPM, 2006

The existing list of IAPM Members [as available and printed in the IAPM News Bulletin Vol 3 May-July 2006] is :

The Honorary Treasurer, Prof Kanaklata Dei has informed that 357 applicants have been proposed for admission into the primary membership of the IAPM:

- ? Payment if any that should be collected for providing the addresses
- ? The office from where this should be done [Ideally the Honorary Treasurers Office]
- **3.6:Problem of presenting authors at Annual Conferences not being members of IAPM**

This year the Honorary Secretary faced tremendous difficulties due to a large number of delegates who were desirous of presenting papers /posters in the annual conference but were not members.

- ? By convention IAPM Membership is mandatory for presenting authors
- ? This year due to on-line submission and computerization detection of such short-coming was easier and at one point of time over 70 delegates did not have IAPM Membership numbers.
- ? Majority of such delegates were postgraduate students [Unfortunately their senior authors who included their teachers who are members of IAPM perhaps did not consider it necessary to guide them in this regard]
- ? Many applied for membership after reminders, SMS and finally a letter with the Proposal Form attached.

These matters were discussed at length. While it was appreciated that students should be encouraged to present papers and posters, it was also pointed out that the constitution of the association cannot be undermined. Hence if any



relaxation was to be made this could be done within the frame-work of the existing rules and regulations and if necessary by bringing out the necessary changes in the constitution.

3.7: Status of Research Scholars who are students for IAPM members at Annual Conferences especially with regard to presentation of papers / posters

Several honourable members are guides of PhD and Non-Medical scientists who do good basic research. Such research scholars cannot present papers / posters [which are otherwise of a high academic quality] in the IAPM Annual Conference due to the membership clause.

Various suggestions were put forward to resolve this issue. The most acceptable one was to include these members as Associate Members only with the clause that they would neither have voting rights nor be able to contest for or hold any official position in the association. In short these members would only have access to and participate in all academic and scientific activities of the association. Apparently similar memberships exist in some of the other scientific bodies/associations in the country.

However it was once again pointed out that these changes could be incorporated after necessary amendments in the constitution.

3.8: Problem of applicants paying only the processing fee of Rs100.00 only.

With the introduction of a processing fee for the membership application, several applicants pay only the processing fee. These applicants later do not even respond. Further the association, especially the Honorary Treasurer is overburdened with the task of tracing such cases. Some students apply with the processing fee to obtain the "Applied For" tag so that they may present papers during our Annual Conference. They may not become members thereafter.

- ? It is requested that applications with the processing fee must not be accepted. At least one year's membership fee must accompany the form.
- ? While it is mandatory to ratify each and every application form by the General Body, some modification in the constitution may be considered so that at least one issue of the News Bulletin and the journal is received by those members who apply within six months of application. This will prevent the complaints of delayed membership after application.
- ? Senior members indicated that since it was enshrined in the constitution of the association that the General Body should ratify all requests for membership, it would not be advisable to deviate from this practice. Hence it was necessary to alter the constitution for this purpose.
- ? One of the suggestion put forth during the meeting of the Executive Council held a day earlier was to provisionally accept membership and ratify later during the General Body Meeting since till date no membership application, correct in all respects has never been rejected by the General Body and ratification is a mere formality.

Resolutions 3.1, 3.2, 3.3, 3.4, 3.5, 3.6, 3.7, 3.8, 3.9/2006

- **3.1/2006 :** All the applicants were accepted for admission to various categories of membership as proposed and completed
- **3.2/2006 :** The New Application Form is accepted and members would point out shortcomings if any. The old form should not be used to maintain uniformity of applications.
- **3.3/200:** State Chapters are requested to ensure that their members are primarily members of the parent IAPM. All State Chapter Chairpersons / Secretaries should provide a list of members to the Joint Secretary and the Honorary Treasurer.
- **3.4/2006 :** All members of the IAPM should ensure that the correct addresses are provided to the Treasurer, Honorary Secretary and the Editor-in Chief, who in turn shall ensure that changes are incorporated to avoid inconvenience to members and update the address book.
- **3.5/2006 :** All members should receive a copy of the address book.
- **3.6/2006 :** The association should continue to provide the Organizers of the Annual Conference of IAPM and the Surgical Pathology CME the address book free of charge. All other commercial organizations may be provided a copy of the address book [not CD] on payment of Page 5000.00 only [Punces five thousands only] to the Tragsurar

co-authors from other specialties who have contributed to the scientific study being presented in a major way should be permitted to present papers / posters in the annual conferences.

- (iv) Acceptance of non-medical scientists as members of the association and if acceptable their status in the association
- (v) Any other matter related to the constitution of the association

The Honorary Secretary was assigned the task of identifying the members of the committee for this purpose.

After much thought and deliberation, in keeping with the vast knowledge, previous experience, expertise and commitment, the Honorary Secretary is pleased to nominate Prof. C.I. Jhala and Prof. Balaraman Nair as core members of the committee. Both Prof. Jhala and Prof. Nair are free to co-opt any other member / members into the committee and seek the assistance, opinion and suggestions of any member as deemed fit.

All suggestions regarding the above matters may please be directed to the Honorary Secretary or to the above respected members of the committee.

The committee would present their suggestions during the next annual conference. As required a special session may be convened for this purpose.

- **3.7/2006 :** All future announcements regarding the annual conference must clearly spell out the eligibility criteria for presentations of papers and posters. These must be adhered to strictly.
- **3.8/2006 :** No application for membership shall be entertained by the association without both the processing fee and the requisite membership fee amounting to not less than the fee for one year or more as the case may be. The Honorary Treasurer can inform all such applicants. Members who propose and second such membership applications are requested to inform the applicants regarding this requirement
- **3.9/2006 :** Since several issues were raised that required modifications and amendments in the constitution, a Committee would be set up to look into these matters. Some of the points that needed attention were:

(i) Status of applicants during the year of application for membership pending current requirement of ratification by the General Body including presenting papers and posters in annual conferences and receipt of journals etc.

(ii) Changes in the procedure for accepting members and any alteration in the status of applicants as in (i) above.

4.3: Nomination of two members for scrutiny and counting of ballot papers for Elections in 2006

The Executive Council proposed two names for the purpose of conducting elections in 2007. These names were considered from members in and around Delhi since the office of the Honorary Secretary is located there. It was felt that since there would be election for several posts in 2007 it would be advisable to count the votes at New Delhi rather than at the venue of the Annual Conference, as was done in the last and this year.

4.4: Discussion on the changes in the system of Postal Ballot

- ? Every year the number of voters is only a fraction of the total membership of the association. Last year a discussion on this matter took place. Various views were expressed including the inconvenience of affixing postage stamps. Since affixing postage for over 3000 ballots many of which may not be posted would be a waste, this year the system of Business Reply Envelopes was introduced. Only the envelopes that return are paid for.
- ? Since counting of votes is preceded by checking the membership status of voters, space was provided in the outer envelope for members to enter membership details. This saved immense time since checking of the



eligibility status was done prior to the actual counting. There was some criticism that an element of bias could enter because the origin of the voter could be identified. The Business Reply Envelope provided an additional cover and also since the post office gives the count of envelopes for their accounting purposes there is no likelihood of any inadvertent or otherwise loss of envelopes.

? Receiving and counting of votes in the conference venue provides easy access for any observer to examine the counting process

All the above changes were brought due to numerous suggestions received from senior members of the association including Past Presidents. The Organizing Secretary, APCON 2006 had helped the Honorary Secretary with the registration for the Business Reply Envelope at the G.P.O. Bangalore and provided all support to ensure that this system worked.

The members welcomed the change an appreciated the assistance rendered by the Organizing Secretary, APCON 2006. However there was grave concern that despite all efforts members did not choose to vote.

Item No. 5 Matters related to constitution

5.1: Use of IAPM Regd. No. 22157/138 of 2005-06 in the IAPM News Bulletin and all publication of IAPM. [This registration number has been accepted by *Income Tax Department*]

The IAPM News Bulletin carries the following "Founded in 1949 & Registered under the Society Act of 1863, Reg. No 669 of 1953-5" since a long time.

The Joint Secretary [Headquarters] has suggested the use of IAPM Reg. No.22157/138 of 2005-06 in the IAPM News Bulletin since this number has been accepted by the Income Tax Department.

The Honorary Secretary also has a Certificate of Registration from the Registrar of Societies, Greater Bombay Region 1977.

It was discussed at length in the Meeting of the Executive Council a day earlier regarding whether all these numbers are to be printed or any particular number should be used. The general opinion was that all available registration numbers should be displayed or printed.

5.2: Introduction of a post of Assistants to various posts (on nomination) for the purpose of operating bank accounts

The Honorary Secretary's Office incurs expenses related to printing of News Bulletin, correspondence related to Annual Conference and with members and expenses related to conducting elections. Similar expenses are incurred by other office bearers, notably the Editor-in Chief. All such expenses are borne by the Honorary Treasurer who transfers the requested amount through a Demand Draft. Due to regulations followed by banks certain observations have been made:

- ? For an Association to open an account an authenticated copy of the Constitution and Bye-Laws is to be deposited in the bank
- ? Cheques should be signed by at least two authorized signatories duly approved by the General Body or appropriate authority of the association and a copy of the minutes thereof should be available with the bank
- ? As far as possible all transactions and payments should be by Cheque or Demand Draft paid to an account.

Dr Niranjan Rout, Past Honorary Treasurer in his letter dated 05.10.06 has reiterated the need for two signatories for operating accounts. He has suggested that Sl No. 14 (viii) Part II of the Rules and Bye Laws of IAPM allows for co-opting a member to assist the Treasurer. He has also suggested

Item No.6 Venue for Conferences

6.1: 56th Annual Conference of the Indian Association of Pathologists & Microbiologists 2007 (APCON 2007)

The Delhi Chapter, IAPM had bid to host the 56th Annual Conference of the Indian Association of Pathologists and Microbiologists [APCON 2007] at All India Institute of Medical Sciences, New Delhi during the annual General Body Meeting of the IAPM in 2005.

Unfortunately the prospective hosts expressed their inability to organize the conference at Delhi in 2007.

The Chairperson then requested the members of the Delhi Chapter, IAPM to identify an alternate venue in Delhi to resolve the matter. The members requested that they be given some time to discuss this matter at Delhi once again since the problem regarding the venue was recent and this could not be discussed prior to this General Body Meeting.

On further requests two other venues were tentatively proposed: Kolkata and Chennai. However since both these venues were proposed without prior verification regarding the availability of suitable venues, the respective members from the two states requested that they be given time to confirm these proposals.

After much deliberation it was obvious that a decision regarding the venue would not be finalized during the General Body Meeting. It was felt that the most reasonable manner would be give time to all the concerned members to discuss the feasibility on their return after the conference and communicate this to the Honorary Secretary later. It was agreed that three chapters were willing, the order of preference for venue of the next conference would be Delhi, followed by Kolkata, followed by Chennai. The Honorary Secretary could take a decision on the venue and if any other chapter was willing to host the conference they would be considered thereafter.

6.2: 57th Annual Conference of the Indian Association of Pathologists & Microbiologists 2008 (APCON 2008)

There has been no offer to host the 57th Annual Conference of the Indian Association of Pathologists & Microbiologists 2008 (APCON 2008) till date. *Resolution* 6.0/2006:

6.0/2006: The General Body empowered the Honorary Secretary to receive in writing proposals to hold the 56th Annual Conference of the Indian Association of Pathologists and Microbiologists [APCON 2007] and to take a decision on this matter.

On return from the conference the Honorary Secretary received written requests for holding the 56th Annual Conference of the Indian Association of Pathologists and Microbiologists [APCON 2007] from Prof. Kusum Joshi [PGIMER, Chandigarh] and Dr. S.R. Srinivasa Kannan [Kanyakumari]. On telephonic conversation, the offer from Kolkata was open. However a suitable venue would be available in the third week of December since prior booking was not available. Prof. Kusum Joshi informed that Chandigarh had hosted the conference 16 years ago. This time the Department of Histopathology, Postgraduate Institute of Medical Education and Research was keen to host the conference in November. Taking all aspects of requests into consideration and delays of flights and trains in winter months, Chandigarh was considered as a suitable venue.

Unfortunately the dates could not be finalized immediately since there appeared to be some overlap with the Annual Conference of the Indian Academy of Cytology at Allahabad. Finally keeping in view the availability of the venue, the dates for the 56th Annual Conference of the Indian Association of Pathologists and Microbiologists [APCON 2007] has been fixed from 27th to 29th November 2007. The conference would be preceded by CMEs and International Academy of Pathology -Indian Divis ion Annual Meeting as is customary. The members of the association may kindly realize the extremely difficult circumstances under which the venue for the next annual conference has been finalized. Nowadays it is very unlikely that a suitable venue for a large conference will be available unless bookings are done much in advance, often over a year in advance. This was the best that could be done.

- ? Such members shall not be members of the council

- They shall specifically assist the office-bearer and be a authorized signatory ? for operating Joint Bank Accounts along with the office-bearer It may be mentioned that the Honorary Secretary had received a letter (undated) from the Honorary Treasurer regarding the nomination of Dr Sukumar Chakravarty (L/1998/1570) for the above co-opted post.

7.4: Proposal for introduction of more Orations to felicitate senior members of the association

There are several senior members of the association who have contributed substantially to the profession, subject and to the association. However he number of Orations and similar honours are limited. With such a large membership, the association needs to invite more Orations and Awards. Such orations may be arranged during the Annual Conference.

In the previous meeting of the Executive Council and the General Body [Indore, 2005], the Indian College of Pathologists had agreed to look into the feasibility of sponsoring such an oration.

The Indian College of Pathologists had decided to sponsor one oration named the every year in memory or in honour of an eminent pathologist. It was requested by the Secretary, Indian College of Pathologists that the Oration be held as the first activity on the morning of the second day during the annual conference. This year the Oration would be named "*Indian College of Pathologists Oration in memory of Dr. S.J.Nagalotimath*".

7.5: Proposal for Guest Lecture at APCON 2007

Dr. D. N. Lanjewar had sent an E-mail to the Honorary Secretary regarding the proposal of Dr Ann Nelson, Director of Pathology, Armed Forces Institute of Pathology (AFIP), Washington DC and Member USCAP- IAP to speak on the following topics:

Members could also convey names of other possible Guest Speakers to the Honorary Secretary.

Item No. 8: Matters related to Awards

8.1: Dr. V.R. Khanolkar Prize 2006

There was no applicant for this Prize this year

8.1.1: Revival of Prize Money & Citation

The Prize money has been discontinued in view of a paucity of funds.

A decision was necessary whether any efforts are possible to revive the prize money or to award only a certificate in future.

8.2: Smt. Kunti Devi Mehrotra Award 2006

One paper and *Curriculum Vitae* was submitted for this award:

Study of p53 and bcl-2 oncoproteins in ulcerative colitis with dysplasia [Med J Armed Forces Ind 2005; 61:125-129] submitted by Sqn. Ldr. (Dr) Prateek Kinra, Department of Pathology, 7 Air Force Hospital, Kanpur

After preliminary scrutiny with regard to eligibility, the paper and Curriculum Vitae were evaluated by three Judges two of whom are Pathologists with special interest in gastrointestinal pathology. Dr Raj Mehrotra was sent a copy for nomination and forwarding to a judge of his choice.

The paper was not awarded the prize.

8.2.1: Revival of Prize Money & Citation

The Prize money has been discontinued.

The Honorary Secretary has been in touch with Prof Raj Mehrotra to make the award attractive and retain its glory.

Dr Raj Mehrotra has requested to place before the Executive Council and General Body his plea that the cash prize should continue. He will send a Draft of Rs.1000.00 only towards the award for the year 2007 and later for 2008. In the meanwhile he would arrange for a suitable corpus for continuing the award. He has also requested to improve the certificate.

This proposal was placed before the Executive Council and the Genral Body for approval.

After discussion it was felt by both bodies that it was necessary to have a corpus rather than an yearly advance towards the cash prize.

8.3: Prof. K.C. Basu Mallick Award 2006

A total of 05 papers were received for consideration for presentation for the Dr KC Basu Mallick award.

After preliminary scrutiny with regard to membership and other eligibility criteria, the papers were evaluated by three referees each. For the purpose of evaluation, a total of ten eminent judges were sent papers. Each papers was evaluated by three judges each and marks awarded for ten predetermined criteria (maximum marks 100). The average of the total marks obtained was calculated for the purpose of ranking. This time all judges were requested to indicate the suitability of presentation of the paper in the Plenary Session .Based on the results of the evaluation, four papers were selected for presentation.

One of the four papers that were presented was recommended for the award by a panel of three judges.

8.4: Best Paper Award 2006

For the Best Paper Award, a total of 08 papers were received.

The eight papers were reviewed to assess their suitability for presentation by a panel of 19 eminent referees [three referees for each paper]. The referees also commented on the suitability of presentation of the papers in the Plenary session. Based on the results of the evaluation, four papers were selected for


