We have to wait to adopt other newer means till we make necessary amendments in our prevailing rules.We are here to follow the ideology of our association only.

We need a change in our election policy to encourage and facilitate more and more dynamic leaders of profession to contest in the election.

I am very much hopeful that more members will come forward to serve the association by taking active part in election by way of filing nominations and casting their valuable votes in support of candidates of their choice.

I welcome the newly elected President and other Office Bearers.

I enjoyed the full cooperation of all members of IAPM and members to the Executive Council 2010 and our honoured Past Presidents in guiding me in taking difficult decisions at crucial moments. I am grateful to all of them. I wish all our members A HAPPY AND PROSPEROUS NEW YEAR 2011.



Report on APCON - 2010, HYDERABAD



The 59th Annual Conference of Indian Association of Pathologists and Microbiologists was formally inaugurated by Chief Guest Lt. Gen. D. Raghunath, Principal Executive, Sir Dorabji Tata Center for Research in Tropical Diseases Innovation center, 11 SC Campus, Bangalore by lightining the lamp on 9th December 2010 at 6.30 pm. Dr. P.V. Ramesh, Director, Nizam's Institute of Medical Sciences graced the occasion as Guest of Honour. Dr. G.N. Mohanty, President IAPM delivered the Presidential address. The Senior Pathologists and Microbiologists from Andhra Pradesh were honoured on this occasion, for their contributions to the association.

A total of 1357 delegates registered for the conference including spot registrations which is a record in recent times. There were six papers for KC Basu Mallik award and two for Best Paper award.
